Dear President Biden,

We, the undersigned 521 organizations across 63 countries in Africa, Asia, Oceania, Europe, North America, Latin America and the Caribbean call on you to take meaningful action ahead of the United Nations Secretary General's September Climate Ambition Summit by using your executive authority to stop expanding oil, gas and coal production, the core driver of the climate emergency.

On March 20, United Nations Secretary General António Guterres <u>declared</u> taking action to stop fossil fuel expansion as a ticket to entry to his Climate Ambition Summit slated for September.

As the world's largest oil and gas producer and number one fossil gas exporter, the United States has a vital role to play in averting the looming climate disaster. The impacts of fossil fuels do not stop at national borders. The United States must support global cooperation on a fossil fuel phaseout and resources for the countries more impacted and less responsible for the crisis, especially in the Global South. But it is also essential that the United States act quickly to phase out fossil fuel production at home. Your administration's domestic policies facilitating more oil and gas production and exports in and from the United States have a direct impact on the lives of communities and ecosystems worldwide.

According to the United Nations Intergovernmental Panel on Climate Change's sixth synthesis report, the science is clear: Even a single new oil, gas, or coal project is incompatible with the Paris Agreement's 1.5°C temperature goal, and we must rapidly phase out existing fossil fuel production. A global just transition off fossil fuels demands the world's biggest historic polluters — first among them, the United States — take immediate and bold action to wind down fossil fuel production and reject false solutions peddled by fossil fuel tycoons. We are counting on the United States to model a science-and-justice-centered approach that ensures no workers and communities are left behind in the urgent and necessary transition to a clean, renewable energy economy.

Despite promising to be a global leader on climate and environmental justice, your administration continues to cater to a handful of wealthy fossil fuel executives who are profiting at the expense of current and future generations. The fossil fuel industry's political and economic dominance has grave global consequences for people in the United States, people around the world, and all life on earth.

Your Department of the Interior should be overseeing a fast and justly managed decline of fossil fuel production. Yet, your administration is actively expanding fossil fuel infrastructure. It is approving new drilling permits at a faster rate than the previous administration. And you recently approved the Willow oil development project in Alaska, defying overwhelming public condemnation from millions of people in the United States and beyond, including the United Nations.

Your Department of Transportation's Maritime Administration should be rejecting deepwater port permits for mega-polluting crude oil export facilities. To uphold your climate and environmental justice goals, your Department of Energy should be a firewall against a flurry of over 20 gas export terminals proposed by industry across the Gulf coast, which could lead to over 1.1 billion metric tons of new emissions.

Agencies like your Army Corps of Engineers continue to approve key permits for fossil fuel megaprojects despite clear legal mandates to protect the public interest — ignoring irreversible climate impacts, environmental justice harms, and egregious Indigenous rights, sovereignty, and human rights violations. Your agencies must reject all permits for new fossil fuel infrastructure.

Before you seek entry to Secretary Guterres's Climate Ambition Summit this September, we demand that at a minimum you commit to:

- Reject federal permits for new fossil fuel projects and revoke illegally granted permits for fossil fuel projects;
- Phase out fossil fuel production on federal public lands and waters;
- Limit gas and all fossil fuel exports to the full extent allowed by law; and
- Declare a climate emergency to reinstate the crude oil ban, accelerate the shift off fossil fuels, boost just and resilient renewables, and advance justice.

These demands are consistent with the calls of Tuvalu, Vanuatu, and other low-lying states to equitably phase out fossil fuels and join a Fossil Fuel Non-Proliferation Treaty.

You cannot claim legitimacy as a domestic or global leader if you continue to speed the destruction of the planet. You must make the United States a first mover in ending the fossil fuel era to right a legacy of historic harms and prevent global climate catastrophe. It's time for the United States to answer the call to protect the future of the planet and use its unparalleled power to show what real climate leadership looks like.
